Mobile Technology Conduct



Only record or post content of others with prior permission
(photos/video/information)



All communication is to be polite and respectful.



Keep your personal information confidential.



Devices are only to be used by the owner.

Mobile Technology Rules



Arrive at school with a charged iPad and a clear deck.



Wait until you are instructed by your teacher before you open the iPad.



Non educational apps must be in your home folder. No unauthorised apps or content.



iPads are not to be used before or after school on College grounds.



You are only to touch your own iPad.



Demonstrate care and respect for your iPad when walking to and from classes.



Emailing during school hours is permitted only when instructed by a teacher.

Inappropriate use of Technology:

- ✓ Parents will be informed of any inappropriate use of Technology.
- ✓ **Parents will not be contacted if iPads are left at home.** It is the student's responsibility to bring their iPad to school each day. Students will still be responsible to complete required work.

1st Incident: iPad will be taken by the teacher and collected at the end of the day by the student. A pink note will be sent home to be signed by parents. The note must be signed and returned to the classroom teacher, in order for the student to use their iPad in class.

2nd Incident: iPad is delivered by the student to the Assistance Principal and collected by the student at the end of the day. If the Assistant Principal is unavailable at the end of the day, the student will collect the iPad the following day. A blue note will be sent home to be signed by parents. The note must be signed and returned to the classroom teacher, in order for the student to use their iPad in class.

3rd Incident: iPad is delivered to the front office by the student. The Head of Primary will email the parents requesting them to collect the iPad with their student at the end of the day or when available.

Primary Learning Technology Acceptable Use Agreement

Family Responsibilities

It is vital that the College community understands the significance of both the use of the Internet and also its potential risks. Parents are expected to encourage responsible use of the internet and monitor the use of technological devices. For example, check the device for appropriately aged apps at home as well as the College. Much of the antisocial behaviour exhibited by students originates at home but can cause serious hurt at school.

- ✓ Parents are requested to disable the use of the messages app on the iPad.
- ✓ Get to know settings>restrictions and how to alter accordingly to suit your child's needs.
- ✓ An Apple ID is required to download apps and other content onto the iPad. The owner of an Apple ID must be at least 13 years old. Therefore, please do not use the student College email address to set this up. Set up a family email account connected with the Apple ID. The Apple ID and password associated with it will allow parent to control what apps their child downloads.
- ✓ Parents acknowledge students breaching these guidelines will be subject to the Primary school consequences.
- ✓ Do not message or email your child during school hours. Please ring/email the College.

The significance of 13 years old

As part of their privacy policies, social networking sites such as Facebook, Twitter and YouTube specify that users must be at least 13 years old. Parents may be unaware of this requirement.

The minimum age stipulations are based on the requirements of the US Congress as set out in the Children's Online Privacy Protection Act.² The Act specifies that website operators must gain verifiable parental consent from parents prior to collecting any personal information from a child younger than 13 years old (O'Keeffe et al., 2011). Many social networking sites avoid this requirement by setting a minimum age of use at 13 years old - but there is no onus on website operators to verify the age of users.
